## Liability Release

**Taxes:** Sales tax from the sale of items at FFHB will be collected by an FFHB representative at the close  
of the event. All persons furnished by Vendor shall be considered Vendors employees or agents and  
Vendor shall be responsible for payment of all unemployment, workman's comp, social security, and  
other payroll taxes, including contributions from them when required by law.

**Release, Waiver, and Disclosure of All Liability:** In consideration of Vendor being permitted to enter  
and participate in FFHB, Vendor hereby releases and forever waives and discharges the producers of  
FFHB from all responsibility for any and all rights, claims, actions, causes of actions demands, damages,  
costs of judgements, medical expenses, liabilities, attorney's fees and legal costs or other compensation  
whatsoever, whether known or unknown, and specifically including any claims based upon any alleged  
negligent acts or omissions by the producers, that Vendor now has or that hereafter accrue to Vendor  
arising out of or related to Vendors entry or participation in FFHB. This release, waiver and discharge is  
binding on Vendor heirs, assigns, executors, administrators and representatives.

**Indemnify and Hold Harmless:** Vendor assumes responsibility for and agrees to indemnify and hold  
harmless the producers against any and all losses, including judgements, damages, costs, expenses and  
attorney's fees, directly or indirectly related to any claim, demand or cause of action arising out of or  
related to Vendors participation in FFHB 2008.
